






Membership Growth Trend Data As of September 30, 2024




Asset Vs. Membership: % Growth Trend Data As of September 30, 2024






Total Loans (\$) ---Year-Over-Year % Growth ---Year-To-Date (Annualized) % Growth




Loan Growth By Type: Year-Over-Year % Growth Data As of September 30, 2024

Loan Origination Trend: By Loan Type (Year-To-Date) Data As of September 30, 2024




Loans Granted: All Loans vs. Real Estate Loans Data As of September 30, 2024




Auto Loan Growth Trend Data As of September 30, 2024


Total Auto Loans (\$) ---Year-Over-Year % Growth ---Year-To-Date (Annualized) % Growth




New Vs. Used Auto Loan Growth Trend Data As of September 30, 2024



Indirect Auto Loan Growth Trend Data As of September 30, 2024




Loan Portfolio Composition As of Data As of September 30, 2024







All Commerical Loan Growth Trend Data As of September 30, 2024

Provision for Loan Losses (\$) Trend Data As of September 30, 2024








Deposit Growth Trend Data As of September 30, 2024




Deposit Growth By Type: Year-Over-Year % Growth Data As of September 30, 2024







Deposit Portfolio Composition Data As of September 30, 2024







Total Investments - Growth Trend Data As of September 30, 2024



Total Borrowings Trend Data As of September 30, 2024








Return On Assets (ROA %) Trend Data As of September 30, 2024




ROA (Annualized) for Asset-Class Peer Groups Data As of September 30, 2024




Net-Worth Capital Ratio Trend Data As of September 30, 2024




Loan-to-Deposit Ratio Trend (%) Data As of September 30, 2024



Asset Quality Ratios (%) Data As of September 30, 2024




Loan Loss Reserves Trend % (Allowance for Loan Losses) Data As of September 30, 2024




Yield Spread Trend Analysis Data As of September 30, 2024







Net Interest Margin Vs. Operating Expense Ratio Data As of September 30, 2024




Efficiency Ratio% Trend (the cost incurred to generate one dollar of revenue) Data As of September 30, 2024



Non-Interest Income/Average Assets Data As of September 30, 2024






(Year-to-Date) Net Income (\$) Trend Data As of September 30, 2024




Gross Revenue Breakdown (\$) Trend Data As of September 30, 2024
